Rules & Regulations

- 1. SR Exposition And Services** (referred as the Organiser) and such individuals as authorised by it.
- 2.The Exhibitor:** Any individual, Company, Organisation or its employees, contractors, sub-contractors, (referred here as the Exhibitors)
- 3.** The Organiser reserves the right for the stall allocation. Change of stall possible with written permission from the organiser, subject to availability.
- 4. Non payment:** The Organiser reserves the right to cancel any stall in case payment not realised.
- 5. Cancellation:** No cancellation after registration. The Organiser may consider cancellation before 90 days, subject to enough valid reasons for the same.
- 6. Damage to the venue:** Fine to be paid (as per the damage done to venue, as calculated by the Venue officer.
- 7. Change of Booth:** Prior written approval is required by the Exhibitors for any changes. The Organiser reserve the right to change the layout.
- 8.** Hindrance near fire points, emergency exits and other key areas not allowed.
- 9.Exhibit Possession/Removals:**
 - a.Exhibitors - raw space possession at 10.00 a.m on 16.12.2026, and shell scheme at 5.00 p.m on 18.12.2026.
 - b.Exhibits must be removed from the booth before 9.00 a.m on 22nd December 2026.
 - c.Should an Exhibitor fail to vacate his booth, space or premises by the time specified above he/she shall be liable to pay any charge or cost incurred by the Organizers as a result of thereof.
- 10.Fascia:** Only one fascia board per booth will be provided. Shell scheme exhibitors are not allowed to change the standard fascia as part of the display. The information provided in the registration form will be used for fascia board at your stand and in the official show directory.
- 11.No Sub - letting:** The Exhibitors may not assign, sublet or grant licences in respect of the whole or part of the stand, Cards, advertisements or printed matter of the firms or persons who are not bonafide Exhibitor may not be exhibited or distributed from any booth except that an Exhibitor may distribute cards, advertisements or printed matter of companies or firms which are subsidiaries of the Exhibitor or the Exhibitor's ultimate holding company.
- 12.Hoardings/Banners:** No hoardings, banners etc. will be allowed at the venue or on the roads in the vicinity unless the design, specification, location and installation have been approved by the Organizers in writing. In case it is not, such unauthorized display is liable to be removed by the Organizers without notice at the exhibitor's cost.
- 13.Exit Permit:** If the Exhibitor vacates before 5 p.m. then penalty of Rs.10,000/- will be levied.
- 14.Right of Entry to Visitor:** The Organizers reserve the right of admission to visitors and may prescribe registration procedure and recover costs from the visitors. Organizers' decision in this matter would be final.
- 15.Verbal Agreement:** Any verbal agreement concerning any aspect of the contract or the exhibition is not valid unless confirmed in writing.
- 16.Jurisdiction:** Any dispute between the Organizers and an Exhibitor is subject to the jurisdiction of the Courts of Delhi (India) only.
